- ii. "B" group Regrade Field #1 to drain properly. Repair the old scoreboard.
- iii. "C" group These are not in any priority order. 1) A.C split system 2) Netting for Field #4 3) Mist Systems 4) Batting Cage Netting 5) Electric Panel at Snack Bar 6) Kitchen table tops 7) Bathroom lights 8) Bathroom walls 9) Patio shade cover 10) Bollards

A motion made by Dale, 2nd by Greg to "Approve the priority list as submitted, subject to only minor refinements and submit to Board in time for December Board meeting" was approved 7-0. Dan will follow-up with recommendation submittal and run by Little League for final glance at the recommendation.

- b. Team Review of FPC Charter Dan Lekawa asked the 3 FPC finance committee members to select a leader and formulate a schedule with Finance Chairman on when certain dates the various items FPC reviews with Finance need to be done by for Calendar year 2025.
